Thanks for the meeting on Nov 3rd and your patience as we put the notes together amidst COP activities and some extended loadshedding / power outages on my side.

The purpose of this mail is to share notes and communicate expectations of any next steps. Our meeting covered various contextual elements from the bank as well as case study examples from members of FFCSA. Our understanding is that content is publicly shareable, besides anything mentioned as confidential.

Key takeaways include:

- 1) **DBSA and the Just Transition:** The aspirational role of DBSA in the Just Transition including local industrialisation and becoming a first lender. Current work includes collaboration between DBSA, PCC, NPC, NT on the Just Transition as well as on Water. FFCSA is open to participating in any working groups or consultations on the Just Transition activities undertaken by the Bank.
- 2) **Civil society engagement:** FFCSA to make proposals on civil society engagement with the Bank including lessons learnt from previous attempts and lessons learnt.
- 3) **DBSA Policies:** DBSA to review the Just Transition Framework document for shareable content and confirm the status of approval.
- 4) **Projects:** Project info related to Powerships and Mozambique LNG
